Entry and Acceptance Procedures

1. The Quilt and Wine Fair in Corrales is open to all Fine Arts and Craft applicants age 18 and older.
2. Applications must be completed and postmarked by May 15, 2010. A description of your work and photos must accompany your application. The photos must depict all your work that you wish to show in your booth if you will be showing various medias (i.e. watercolor paintings, oil paintings). Up to five (5) photos of your work may be submitted.
3. Applicants will be notified by phone or e-mail of their acceptance.
4. All exhibitors are provided 10'x10' space. Exhibitors must provide their own tent, display equipment, lighting, etc. All booths must be tented. Tents may be rented for \$150. Booth fees are \$200 per 10'x10' space.
5. All work exhibited must be original work created by the exhibitor. No commercial, manufactured or kit work will be allowed. Reproduction of exhibitor's own work is acceptable (i.e. prints, note cards). Only work accepted through this application may be exhibited. Reproductions of the artist's original work can only encompass 1/3 of their booth.
6. Exhibitors must personally attend their booth and be present during the entire event. All exhibitors are responsible to keep their booth area clean during the event.
7. Exhibitors must clean their booth area following take-down after the event.
8. 24 hour security will be provided during the event. However, it is suggested that entrants carry their own insurance. Neither Corrales Festivals LLC organizers, sponsors, their officers nor volunteers, will be held responsible for loss or damage to any work.
9. Booth setup is allowed from 8:00 a.m. – 11:00 a.m. on Saturday, August 7th. All booths must be set up and ready for business no later than 11:00 a.m. The fair hours are from 12:00 p.m. – 6:00 p.m. each day. Booth takedown will begin at the close of the event at 6:00 p.m. on Sunday, August 8th. Exhibitors are not allowed to take down their booths prior to 6:00 p.m. on Sunday, August 8th. No security will provided after 6:00 p.m. on Sunday.
10. Parking and badges will be provided to each vendor, plus one additional person representing your booth. All applications are due by May 15, 2010. Please mail your application to **Lisa Kirkpatrick, Art/Craft Entry, PO Box 1189, Corrales, NM, 87048.**
